- Along shorelines of lakes, reservoirs, and potable waters.
- Koi ponds, fishponds, stock ponds, and garden ponds.
- Golf course ponds, irrigation ponds, and residential retention ponds.

## What is a Precision Dose Unit or PDU

A Precision Dose Unit or PDU is a precise dose of product to treat 1 acre foot of water or 1 acre for foliar applications. 1 PDU is equivalent to 16 ounces or 1 pint.

## How to Apply



This product mixes readily with water. Add 1 PDU to 2 gallons of water in a pump up sprayer.




Close sprayer and shake/swirl well.



Slowly walk around your shoreline spraying directly over the surface of your waterbody.

**2 PDUs of this product will remove 0.2 pounds of Phosphorus, or 18ppb of P out of a typical pond (1 acre at 4ft), or 74ppb out of 1 acre-foot of water.**



## When to Apply

This product can be used year-round to inactivate Phosphorus within your water column. Use routinely (bi-weekly/monthly if continuous inputs to your system (waterfowl, well water, stream inflows, run-off etc.)

## Tips For Best Results

- Distribute SePRO ReSTORE WC uniformly over the surface of the waterbody or the area targeted for phosphorus inactivation.
- **Static ponds (farm ponds, fish ponds)**
  - Use 10 PDU in spring and 5 PDU in mid-summer per acre.
- **Intermittent flow (HOA Retention, Golf course)**
  - 5 PDU monthly starting in spring.
- **Heavy inputs (Stormwater, constant stream)**
  - 4 PDU every two weeks.

**Do not apply more than 8 PDUs per acre-foot of water.**
